

## **GOODS PROHIBITED FOR SHIPMENT FROM AZERBAIJAN**

**Dear User,**

**The following is a list of the goods and items that are not permitted to be shipped from the Republic of Azerbaijan:**

- ❖ Information systems, records, and archives related to Operational and Investigative Activities carried out by of the Ministry of Defense, State Security Service, State Border Service, and Ministry of Internal Affairs of the Republic of Azerbaijan.
- ❖ Documents of the State Archive Fund
- ❖ Original copies of the documents with engraved State Coat of Arms
- ❖ Documents, inventions, and projects of State importance
- ❖ State standards of the units of quantity
- ❖ National cultural property, items on the official National Cultural Property List of the Republic of Azerbaijan, excluding the items taken for temporary exhibits, tours, restoration projects, lectures, and foreign cultural events
- ❖ Rare plants included in the Red Book of the Republic of Azerbaijan, deer and roe deer antlers
- ❖ Precious wood species (walnut, chestnut, linden, oak, beech, ironwood)
- ❖ Special means of confidential communication, literature on their coding and use
- ❖ Raw precious metals and precious stones
- ❖ Equipment for issuing money and postmarks
- ❖ Coins, bank notes or traveler's checks
- ❖ Firearms and ammunition, any military-related commodities, explosives, military equipment
- ❖ Radioactive substances
- ❖ Narcotics and psychotropic substances, accessories for their usage
- ❖ Materials promoting and advertising moral depravity, violence, and terrorism

- ❖ Materials pertaining to the technology for the manufacture of narcotic, psychotropic, toxic, and explosive substances
